1. Outfitter agrees to provide a semi-guided or fully guided hunt to "hunter" on property leased or owned by Outfitter on the dates of \_\_\_\_\_, 2007.

2. Hunter agrees to pay Outfitter the sum of \$750 for a deposit to be applied to the hunt price of \$\_\_\_\_\_ for the right to hunt and or harvest a deer or turkey on said property. Harvest is not guaranteed.

3. Hunter agrees to provide and accept charges for any unpaid balances for any additional hunting expenses or fines on \_\_\_\_\_ credit card with # \_\_\_\_\_ and expiration date of \_\_\_\_\_ or by paying with personal check or money order.

4. Hunter agrees to pay a \$500 fine for harvesting any deer scoring less than 135" Boone and Crocket scoring complying with Outfitters 140" minimum.

5. Hunter agrees to accept responsibility for purchasing and obtaining any license and permits needed to fulfill all legal obligations required by law to hunt with archery or firearm on any property hunted by Outfitter on the dates agreed to above and keep in possession at all times while hunting.

6. Hunter agrees to hunt in only the areas or stands designated by Outfitter or their guides. NO walking or scouting around without prior permission is permitted.

7. Hunter agrees to accept all responsibility for any damages imposed on any property while he or she is hunting.

8. Hunter agrees to be free of any influence from any illegal substance, drug, or alcohol while hunting.

9. Hunter accepts all responsibility and risk from injury or damages received from the use or application of any stand, equipment, or hunting device. Hunter agrees to enter into or out of any tree stand or structure at

his or her own risk accepting all responsibility for the use and condition of that property or equipment. A safety harness or vest is required at all times while in, entering, or descending from a stand.

10. Hunter accepts the responsibility and risk of all hunting activities and along with all heirs, representatives, and next of kin, hereby releases, waives, discharges, and covenants not to sue or hold in any way responsible, Xtreme Management Hunts, LLC, Landowners, their agents, lessees, employees, guides, personal representatives, assigns, heirs, and next of kin responsible, liable, (hereinafter releases) from any negligence, injury, damages, personal injury (including death), or other damages to personal property occurring before, during, or after hunting or traveling to or from any property hunted or used by Outfitter or Landowners. Hunter hereby accepts all responsibility and risks of damages, personal injury, or death to his or her person or property while on any property owned, leased, or used in any manner by Outfitter rather caused by negligence from any function of Outfitter or his representatives or not.

11. Hunter agrees that the release, waiver, and indemnity agreement is intended to be as broad and inclusive as permitted by law in the State of Illinois.

12. Hunter agrees that all provisions of this agreement are understood and applicable.

13. Hunter understands and accepts that any breach or disregard of any rules set forth in this agreement terminates all rights to any hunting on any property used by Outfitter and forfeits all payments and accepts all debts for any unpaid balances.

14. Hunter agrees to not lease, hunt, or engage in any plan to use any property used or hunted by Outfitter for 5 years.

15. Deposits are non refundable and will be applied to the next years hunt if cancellation is prior to June 30<sup>th</sup>.
